**ANA 2011 Exhibit Entry Information**

**Rules of Eligibility**

1. Work must be original, not done under supervision and not previously shown in this exhibit.
  2. All 2- and 3-dimensional media, including photography, are eligible.
  3. You may enter 3 works of art, but there is a limit of 2 works per artist that may be selected by the juror. An artist is eligible to win only one (1) award (ACO Postcard Award, People's Choice, ACO Director's Award excepted).
  4. Diptychs and triptychs must be in one frame.
  5. Giclee prints are not eligible. Photography must not be digitally manipulated and must be on photo paper only.
  6. Pastels under glass will be accepted with a signed waiver. Forms are available. Other art work requiring protection must use Plexiglas.
  7. Artists must be at least 17 years of age to enter.
- Measurement Restraints (no exceptions):
1. Art work to be hung cannot measure over 50 in any direction.
  2. Art work cannot have a total measurement of over 80. (Total measurement is obtained by measuring from outside of frame horizontally and vertically, then adding the two together.)
  3. All framed art must have eye screws, strong wire attached and be ready to hang.
  4. 3-Dimensional work cannot weigh over 100 lbs.

**Method of Entry Digital Files on CD**

1. NO SLIDES. Digital JPEG files on CD only.  
CDs WILL NOT BE RETURNED
2. Fees and entry materials must be mailed to ANA, P.O. Box 3286, Fayetteville, AR 72701 postmarked by May 25th, 2011

**Digital Entry Requirements**

1. JPEG format, Quality 10 or best, 1024 pix (maximum), 300dpi (300 dots per inch resolution) on CD.
2. Digital entries shall be upright and not in need of rotation to view.
3. Digital entry file names MUST MATCH THE ENTRY FORM.
4. All entries on same CD. NO OTHER FILES on CD. NO MULTIPLE COPIES OF SAME ENTRY on CD.
5. All CD's should have artist's name on them and be in protective covers.

**Entry Fees**

1. For one or up to three entries, \$30 for ANA members \$35 for non-members.
2. Make check payable to ANA.

**If your art work is accepted for the exhibit, please read the following sections carefully:**

You may personally DELIVER (carry-in) your art work to the Arts Center of the Ozarks (ACO), 214 S. Main Street, Springdale, AR, Saturday July 30, between the hours of 9:00 a.m.- 3:00 p.m. You will be responsible for picking up art work at the end of the show, OR you may SHIP your art work by using our shipping agent.

If you prefer to use our shipping agent, shipping instructions will be sent to you. You must insure your package and if it arrives damaged, it will be returned unopened. A local shipping agent will charge \$75 per one/\$125 per two shipped entries, plus return postage. They will accept your package, deliver it to the ACO, unpack it, store crating material, pick up art after the exhibit, repackage and ship it back to you.

*Shipped work to arrive by July 23rd.*

EXHIBIT CLOSES on Aug. 26th. All art work must be picked up Aug. 27th between the hours of 9:00 a.m. and 3:00 p.m. After 30 days unclaimed artwork will become the property of ANA.

NOTE: If a designated person will pick up art work, please let the ANA show chair know in writing.

***DO NOT CALL OR SHIP ENTRIES TO THE ACO.***

Final selection of awards will be made from actual objects. The juror reserves the right to reject work not accurately represented in CDs.

IF YOUR ARTWORK IS SOLD DURING THE EXHIBIT A Commission of 30% will be charged. (20% will go to Arts Center of the Ozarks and 10% to Artists of Northwest Arkansas.) Neither sponsor, shipping agent, nor ACO will be responsible for loss or damage. Although we will strive to handle your art work with utmost care, you must insure it.

**Juror:** RICHARD STEPHENS is a native of Hot Springs, Arkansas, and graduated from the University of Central Arkansas in 1969 with a degree in art.

After serving in the Army as an illustrator, he began his commercial art career in 1971 with a design studio in Little Rock. There, he began forming a network of other artists, vendors and suppliers that allowed him to open his own studio in 1974 and has been freelancing out of Hot Springs since that time. After discovering the medium in college he always knew watercolor was his real "calling". Occasionally it would emerge, but he didn't start painting consistently again until 1992.

Stephens was recently named as one of ten "Artist to Watch" by Watercolor Magic magazine (December 2005 edition). Four of his paintings were featured in 200 Great Painting Ideas for Artists, by Carol Katchen, published by North Light Books.

Stephens' work is owned by individuals and corporations around the country. He is a member of the Arkansas League of Artists, the Mississippi Art Colony, and is a signature member of Mid-Southern Watercolorists, Southern Watercolor Society and Missouri Watercolor Society.
